A product is already considered faulty when it is delivered without a user manual or not in the language of the respective country!

A correct and informative user manual not only offers protection against liability claims resulting from the altered legal guidelines, it also offers additional benefits:

- A user manual protects the user from damages due to miss-use and thus protects the manufacturer / dealer from any resulting liability claims
- A user manual functions as a marketing tool and therefore increases the value of products
- A user manual serves as an excellent tool for increased and improved customer relations benefiting both the dealer and the consumer






The **standard version** offers a uniform appearance for smaller quantities, non-branded bicycles/frames or individual dealer build-up.

Brand version


As above in standard version, additionally cover pages can be customized with brand and/or corporate logo, minimum order quantity 1000 pcs with other productions, 2000 pcs individually.
